2022 – an eventful year for First Camp


- Continued expansion
 - Entered Norway, currently three Norwegian destinations
 - Leksand Resort acquired in March 2022
 - Another four single-site acquisitions
- Reached milestone of 1 bn SEK in revenues
- Commercial initiatives paying off well (e.g., B2B sales, Revenue Management)
- Record-high guest satisfaction (NPS)
- Strong demand in market, high cost inflation
- New First Camp website launched, cementing First Camp's position as the largest booking channel in Scandinavia for camping and cabin stays





Strengthened market position in Dalarna region thanks to acquisition of Leksand Resort

- Dalarna is on the top five-list of the most popular camping regions in Sweden
- Leksand Resort complements existing six First Camp destinations in Dalarna
- Five-star campsite, 222 cabins, Leksand Sommarland, Moskogen Hotel & Konferens and extensive Food & Beverage operations
- Synergies include package sales with First Camp sites and Leksand Sommarland








B2B revenues have doubled in just three years (like-for-like)

- Focus on B2B sales (long-stay accommodation for companies) since 2019 has paid off well
- Central sales resources working closely together with local teams at destinations
- Combination of ad-hoc orders and framework agreements (incl. one recently signed with Swedish Försvarsmakten)
- Furthermore, First Camp Group & Conference concept launched in 2022 with further potential

- YouTube channel is No. 1 in Denmark among children (170 million views)
- Gives high share of returning customers and strong pricing power

Thematization now being rolled out at First Camp-branded destinationes

- Yessi Kids Club concept launched in 2020
- 105 000 participants in the summer of 2022
- Five cabins with Yessi themed opened in 2022 as pilot test
- More to come in 2023

Continued strong growth pipeline in 2023

- M&A processes ongoing in several countries with several signed LOIs
- Ambitious project plan for 2023 in increasing accommodation capacity at existing destinations, and many opportunities remaining
- Commercial initiatives to drive further organic growth, incl. implementation of CRM system

As well as measures to optimize costs – examples:

- Central staff scheduling to optimize staff costs at destinations
- Large energy savings program launched in August 2022; generating a 19% like-for-like reduction in energy consumption in Q4 2022
- Further capex investments to reduce energy consumption are being rolled out
- Scenarios being developed if demand would be weaker than expected during summer
- AI-based technology for optimizing digital marketing spend
